Tinmog (Morgan Sports Car Club, Cornwall Centre) respects your privacy and we will only use your information in the way we describe in this notice and the Centres' Constitution.

When using your information, we aim to be fair and transparent, to follow our obligations under UK data protection laws. Your information is used for administrating club membership, activities and events. Tinmog is the data processor for the purpose of the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. Our club contact for privacy details is the Centre Secretary. Collecting your Information

We collect your information when you fill in your membership application or renewal forms and event entry forms. The information may include your contact details (name, address, telephone number, email address), personal information (MSCC membership number and details) and vehicle details. If you need to give us information about another person, for example, an emergency contact number, you should inform that person that you have given us the information.

Using your Information

We use your information when you first apply to become a member of Tinmog and then to administer and renew your Club membership. We also use your information to inform you of centre events and when you enter or attend Club events.

We will not use your information for any other purpose without your prior permission

Sharing your Information

We may share your information with:

The Motorsport UK (formally MSA) as required by its General Regulations for governing motor sport.

We may have to share your information to comply with a legal obligation.

We do not sell or give your information to any other organisation.

Our Website, Facebook page, Miscellany and centre emails

No membership list is accessible on our website or our Facebook page.

If a member is organising an event and gives permission for us to use their contact details then this will show only the information they agree to. If they do not wish to use their contact details then they can use the appropriate centre email contact address i.e events@tinmog.org.uk

Media content

Media content can be defined as any digital type of data, such as Pictures, Video, Music, Sound recordings and so on. Any of this type of media which is posted on our site by individuals is freely given to the site and the individual doing so should ensure that there is no infringement of Copyright or ownership by a third party. If permission has not been given and infringement has been made, the matter should be taken up with the Webmaster or Centre Secretary who will investigate and take appropriate action.

Security for your Information

Your information is held securely by us. We have taken all reasonable steps and have in place appropriate security measures to protect your information. Your details are held in an electronic format, they will be protected by password. The Membership Secretary may hold your membership form in paper format and will ensure it is held in a secure location.

Ceasing to be a member of the Centre

When you cease to be a member of the centre, your details will be reduced to skeleton information that will include your name, MSCC membership number, Vehicle reg and years you were a member. This will be kept to meet any legal obligations or answer MSCC queries.

Your Rights

You are entitled to a copy of the information we hold about you and to ask us to correct any inaccuracies.

You may ask us to stop using your information, and to delete it. If you ask us to do this, we will not be able to continue our contact with you, although we maintain a skeleton set of your information to meet any legal obligations.
